Cardinal District Committee Meeting November 17, 2022

There were 18 committee members in attendance by Zoom.

District Chairman's Remarks

Members should have received a copy of the proposed minutes for the October 2022 meeting. A motion was made for approval of the minutes. Second and discussion. Minutes approved.

The Occoneechee Council Executive Board met today at noon. The treasurer reported that revenues were above budget and that the council is in good shape fiscally. The board approved the proposed budget for 2023. Some budget assumptions included an increase in the weekly camp fee to \$400 for youth and \$175 for adults. A 6% (average) raise for council employees was included and personnel costs will include adding an Exploring Executive, two District Executives, a Development Director, and a second Camp Ranger. There were also repairs to camp properties budgeted.

Term limits for council board members-at-large have been under study by Matt Nash and students from the Fuqua School of Business at Duke University. Matt will be conducting listening sessions in December 2022 to gather additional input before presenting a formal resolution for the board to consider some time in 2023. There will be no changes taking effect in 2023.

The most important item on the agenda was the resolution adopting a policy for the creation of Council-Registered Units (CRUs). For those of you who are not already aware, BSA and the US Conference of Catholic Bishops (USCCB) announced one week ago that BSA and USCCB had reached agreements "enabling us to continue our long-standing relationship." Those included new chartered organization agreements for Catholic churches, as well as affiliation agreements and facilities use agreements. It is going to be up to the individual dioceses as to how they want to continue the Scouting program. The Raleigh Diocese has advised they have not yet received any formal guidance from the USCCB and Scouting units chartered to Catholic churches and men's organizations in the diocese would continue as usual for 2023 (although probably using the new form chartered organization agreement). If the Raleigh Diocese decides not to recharter units next year, the Council will follow the policies and procedures established for UMC units this year.

While not voted on by the council board, Occoneechee Council did publish last week its "Council Registered Units Requirements and Responsibilities" that outlines how the council is going to implement CRUs along with two information sheets from BSA National. I have sent everyone copies of those documents, and I do not plan to try to get into the details this evening. Right now, we are expected to have about 27 CRUs in the council and 11 CRUs in Cardinal District. Obviously, the situation is continuing to evolve, and the ad hoc council committee and staff will be continuing to work out the details for the transition to CRUs and their administration. The council is still clear in its desire that CRUs be a bridge until a unit can get a traditional charter partner, but one council board member remarked during the discussion that as more and more charter partners pull back or end their relationship with Scouting CRUs may very well become the norm.

A reminder - our annual Cardinal District Business Meeting will be on Saturday, January 7, 2023, from 9:00 am until noon at Saint Francis United Methodist Church in Cary.

The District Nominating Committee is finishing up its work and we anticipate sending the nominating committee report out to the District Committee on or before December 7, 2022, a month before our annual business meeting.
