# Cardinal District Committee Meeting October 20, 2022

There were 18 committee members in attendance by Zoom.

#### District Chairman's Remarks

A motion was requested for approval of the September 2022 meeting minutes. The motion was made, seconded, and the minutes were approved.

An update on the BSA bankruptcy case was given. While the two largest insurers and 86% of claimed abuse victims approved the BSA reorganization plan and settlement, a number of insurers providing excess liability coverage (Travelers, Liberty Mutual, etc.) and a group of abuse claimants have appealed confirmation of the plan to the US District Court for the District of Delaware. While BSA is saying it hopes the appeals will be resolved by early next year, Reuters and other news outlets are reporting the appeals could delay BSA's exit from bankruptcy by a year or more.

One of the problems with the delay in implementation of the reorganization plan is that changes to Youth Protection will probably also be delayed. Occoneechee Council's and Cardinal District's YPT certification rate has dropped to about 92%, consistent with the national average. Bob Shelton, our council YPT champion, advises that there will be no changes to YPT before the end of the year. BSA is considering looking at making YPT certification effective for 26 or even 36 months with certain refresher training. However, we may not see any changes until the appeals are resolved. Please make sure your YPT certification is current.

As for the issues concerning UMC-chartered units, Occoneechee Council Executive Board passed a resolution on September 22, 2022. While short on specifics, the resolution did state that the council was leaving the door open to council-registered units (CRUs). The Council Executive Board will meet again on November 17, 2022. Unofficial information is that the board will approve the use of CRUs for those UMC-chartered units that have not found a new charter partner. Additionally, the unofficial information is that the council will pass through insurance costs to the units (such as insurance for trailers) but will not impose an administrative charge, at least for 2023. Unofficial sources also report that BSA nationally is discouraging the creation of nonprofit 501(c)(3) organizations for the sole purpose of serving as a chartered organization after this was suggested as an alternative earlier to UMC-chartered units. To further add to the uncertainty, news reports said that as many as a third of the churches in the North Carolina General Conference of the UMC will or may vote to disaffiliate and be part of the new Global Methodist Church. Where the GMC stands on chartering Scout units is unknown.

Our ad hoc group to review our district Pinewood Derby rules met last evening. We agreed on some minor changes to the rules used last year, to include 1) taking out "parallel wheels" and "four-wheel touching" requirements that had really just served to disqualify Cubs who had tried their best to build their own cars and 2) clarifying that Webelos and AOLs would compete as separate groups. With no objections stated, the final rules will not be brought back before the full district committee for a vote but will be published to the packs by mid-November. Gantt reminded everyone that the updated rules

and information will need to be posted to the district web pages. Thank you to David Crowley, Jamie Mueller, and Craig Smolen for working on this project.

A reminder - our annual Cardinal District Business Meeting will be on Saturday, January 7, 2023, from 9:00 am until noon at Saint Francis United Methodist Church in Cary.

Our First Vice Chair Tim Forrest is again serving as chair of our District Nominating Committee, and the committee is hard at work. Tim provided a brief update on the nominating committee's work. The committee has contacted most members of the district committee to assess their interest in continuing to serve and will be issuing its report by early December.
